**ABSTRACT**



Announcement made by the Hon'ble Minister for Labour during the Assembly Session 2020-2021 - Enhancement of stipend provided to all the trainees of Government Industrial Training Institutes (ITIs) from Rs.500/- per month per trainee to Rs.750/- per month per trainee - Rs.8,62,18,000/- sanctioned as recurring expenditure towards award of stipend - Orders issued.

**ORDER:**

In the Government Order first read above, orders were issued to enhance the stipend provided to all the trainees of the Government Industrial Training Institutes (ITIs) to Rs.500/- per month per trainee.

2. During the Assembly session 2020-2021, the Hon'ble Minister for Labour has made the following announcement on the floor of Assembly on 24.03.2020:-

“அரசு தொழிற்பயிற்சி நிலையங்களில் பயிலும் பயிற்சியாளர்களின் வாழ்வாதாரத்தை உயர்த்திடும் வகையிலும், பெருகி வரும் செலவினங்களை கருத்தில் கொண்டும் இந்த ஆண்டு முதல் அனைத்து அரசு தொழிற்பயிற்சி நிலையங்களில் பயிற்சி பெறும் பயிற்சியாளர்களுக்கு மாதந்தோறும் வழங்கப்படும் உதவித் தொகையானது ரூ.500/-லிருந்து ரூ.750/-ஆக உயர்த்தி வழங்கப்படும்.”

3. In the letter second read above, the Director of Employment and Training has stated that, as per National Council of Vocational Training (NCVT) norms, the trainees of ITIs are to be provided with stipend. Providing stipend not only helps the trainees to offset their incident and daily expenses and also acts as an enabling incentive to attend classes regularly. The inflation rate for food items in 2012 was 7.3%, but in 2020 the food price inflation has surged to 14%. It has doubled in these eight years, so considering the high cost of living, it is proposed to enhance the stipend issued to the trainees from Rs.500/- to Rs.750/- per month. This stipend will be provided to the trainees throughout the training period of 10.5 months as per revised Directorate General of Training (DGT) norms. A stipend of Rs.500/- is already being awarded to

these trainees. So the additional cost per trainee is Rs.250/- per month. The additional cost involved in providing enhanced stipend of Rs.750/- to 34574 trainees of all Government ITIs in the State is as follows :-

4. The Director of Employment and Training has requested the Government to issue the following orders:-

- (i) To permit to enhance the stipend of Rs.500/- per month per trainee to Rs.750/- per month per trainee through ECS to all the trainees of Government ITIs.
- (ii) To sanction a sum of Rs.8,62,18,000/- as recurring expenditure towards award of stipend to the trainees of all Government ITIs.

5. The Government after careful examination of the proposal of Director of Employment and Training, accept the same and issue the following orders :-

- (i) The stipend provided to all the trainees of Government ITIs through ECS is enhanced from Rs.500/- per month per trainee to Rs.750/- per month per trainee.
- (ii) Sanction is accorded for a sum of Rs.8,62,18,000/- (Rupees eight crore sixty two lakh and eighteen thousand only) as recurring expenditure towards award of stipend to the trainees of all Government ITIs.

6. The expenditure sanctioned in para 5(ii) above shall be debitable in the following heads of account :
